### Rules and Regulations

**\*Each Participant is required to read and sign the following release of liability agreement.**

Open to all customs, rods, muscle cars, trucks, and motorcycles. Entries are limited and subject to the discretion of Cruisin' for Down Syndrome or the NDSCoalition staff. Entrants must be 18 years of age to participate in street cruise. All registered vehicles must carry proof of automobile liability insurance with minimum of \$15,000/\$30,000 bodily injury \$10,000 property damage. **Proof of insurance must be shown at check-in for the car registered.** All registered vehicles must have current DMV registration. All registered vehicles will be issued a window plaque with identification number for that vehicle. Vehicles must display window plaque on the passenger's side of the windshield at all times. Switching of window stickers from one vehicle to another or coping the sticker and placing in another car is prohibited and will result in eviction from the event. **Any vehicle found parked or driving in the cruise without the proper window sticker will be ticketed and evicted from the cruise. Wristbands must be worn,** without a wristband the entry into the Supercharged Chili Cook Off wine & beer event is \$20.00 per person. **Alcohol is not allowed at any street event (i.e. cruise).** The directors and event management of Cruisin' for Down Syndrome reserves the right to restrict entrants to acceptable behavior during any and all activities. For any reason an entrant or his/her vehicle, their appearance or conducts are deemed objectionable by the directors or management, entrant and his/her vehicle will be evicted from the event. This includes, persons, things, conduct, printed material or any act or item of poor character considered objectionable. No refunds will be returned in the case of an eviction. There will be no bicycles, scooters, roller blades or skateboards allowed in during the Cruisin' for Down Syndrome event. In consideration of acceptance of participants to the show Cruisin' for Down Syndrome on June 26 & 27, 2009 by execution of this entry form, I hereby release the National Down Syndrome Coalition, "Cruisin' for Down Syndrome" and their members, officers, employees, or anyone else connected with this event from any known or unknown damages, injuries, losses, judgments, and/or claims from any causes whatsoever that may be suffered by anyone participating in this event, or by any spectators. Any participant breaking traction or with open exhaust will risk immediate expulsion from the show. All regulations of Cruisin' for Down Syndrome, laws and traffic laws of the City of Auburn and Placer County, CA. will be strictly enforced. I also authorize the use by the **NDSC** of any photo, film, or videotape taken of me or my minor child at the event for any purpose. By signing, I have read and understand this Release of Liability Agreement.
